The Australian Cyber Security Centre (ACSC), based within the Australian Signals Directorate (ASD), has published a useful set of online resources that discuss the controls to put in place to keep your organisation secure.

While no set of mitigation strategies are guaranteed to protect against all cyber threats, organisations are recommended to implement eight essential mitigation strategies from the ACSC's Strategies to Mitigate Cyber Security Incidents as a baseline. This baseline, known as the Essential Eight (E8), is designed to increase the security posture of your IT systems and make it harder for adversaries to compromise your organisation.

The eight mitigation strategies that will help protect your organisation include:



While these strategies aim to help businesses mitigate the likelihood or impact of threats, it must be noted that the Essential Eight outlines a minimum set of preventative measures.
